Changed the wording to read: To annually, at the AGM, in consultation with the appropriate bodies and as set out in the Modus Operandi's (Annexures to the KBA By-Laws), announce Conveners and StandingCommittees for – 3.8.3 Removed Inter-District

#### **MOTIVATION**

Modus Operandi for all standing committees are in place as Annexures to the KBA By-Laws which explain the processes. The Player's Association is not only for Inter-District players.

#### 6. ARTICLE 6.2.11

Added this article and it reads as follow:

In the event of the closure of any bowling club affiliated to the KBA, any assets, after liabilities have been met, shall be given or transferred to KBA, together with all records, including its dissolution or closure records, minute books and books of account.

## **Motivation**

This will enable KBA to ensure that the closure of a club is dealt with in accordance with good governance and in an orderly manner.

Replaced the total paragraph to read as follow:

By 3 December, a return showing its total enrolled membership classifying Life Members with full privileges, ordinary members liable for the full subscription, students liable for

Bowls SA subscription and dual members, differentiating between KBA district and other districts. Dual members from other districts will be liable for the KBA subscription. This return to be in alphabetical order and include their Bowls SA number. This return must tie up with the Bowls SA database of 30 November.

## 10. ARTICLE 8.2.3

## 13. ARTICLE 9.2.3

Added: NO member of the Executive may serve on the KBA Executive Committee and their club Executive Committee simultaneously.

## 14. ARTICLE 15.2

Removed "Keep BSA database updated"

## Motivation

Not the District Secretary's duty. Clubs do this.

# 15. ARTICLE 17.5

Removed "submit ranking returns to B.S.A" and added "keep database updated.

## Motivation

KBA does not have a ranking system in place, and it is the Competition Secretary 's duty.

## 16. ARTICLE 19.1

Changed 15 December to 15 January.

## Motivation

To be in line with our financial policy.

# 17. ARTICLE 29

Removed the entire Article

## **Motivation**

This article is now covered in the KBA Modus Operandi Selectors and is an annexure to the KBA By-Laws.

# 18. **ARTICLE 31**

Changed the number to Article 29 and added subject to the approval of the Executive.

# **Motivation**

To take the place of Article 29 which was removed.

## 19. ARTICLE 30

Added the removed Article 12 in the KBA By-Laws to this article.

## **Motivation**

It is more appropriate to have a full explanation of the disciplinary procedures in the constitution and not in the By-Laws.

## 20. ARTICLES 32-36

Article numbers changed to 31, 32, 33, 34 and 35.

# **Motivation**

To follow Article 30 in numerical order.
